Scholarships and grants for the manufactured housing, RV and campground industries

The HARVEST Education Foundation is the educational outreach arm of the Michigan Manufactured Housing, Recreation Vehicle and Campground Association. HARVEST is a not-for-profit corporation formed under the 501(c)(3) code of the United States Internal Revenue Service.

Who is eligible for a scholarship or grant?

Awards are available for MMH & RVCA members and their employees.

How can the grants and scholarships be used?

Member awards can be used for underwriting costs for one or several employees to attend an industry-specific education course, conference or seminar. Educational subjects can range from management to technical training. **Educational providers can be from industry associations, colleges, private training schools or manufacturers.**

What would be the amount of the scholarship or grant?

The amount would vary with each individual application and the resources of the foundation. Awards would be considered only for costs related to course or program registration fees. Depending on its financial ability, the foundation may elect to pay up to half of the cost.

How is the scholarship or grant awarded?

You will be reimbursed upon receipt of proof of payment (i.e. canceled check) and proof of course/program attendance (i.e., completion certificate). Copies of documents are acceptable.

Who would decide eligibility and make the actual awards?

A committee of the HARVEST foundation board would make the determination of eligibility and the amounts of the awards.

What is the time frame for applications?

The foundation would need a 21-day lead on applications.

Where do I send my application form?
